SECTION 1. OBLIGATION OF PHASE 2 FUNDING

Under this Amendment, and in accordance with the terms and conditions of the executed Grant Agreement for FHWA TIGER II Grant No. C-19, the Government and Grantee acknowledge the completion of the portion of Phase 1 of the Project related to Phase Two, and that the Grantee has met all Federal, State, and local requirements required prior to the start of final design and construction of Sections 7 and 9 in Rogers. Therefore, in accordance with paragraph 4.2 of section 4 of the Grant Agreement, the amount identified in paragraph 1.3 of section 1 of the Grant Agreement for Phase 2 – ONE MILLION FOUR HUNDRED FORTY-NINE THOUSAND SIX HUNDRED Dollars (\$1,449,600) – will be obligated for performance of Phase 2, which includes final design work and construction of Sections 7 and 9 in Rogers.

SECTION 2. TERMINATION

Section 5 of the Grant Agreement is amended by adding the following:

"5.1.2.1 The Grantee fails to begin work on Phase 2 before October 31, 2011;".
