(1) CALL TO ORDER

The in-person and virtual NWARPC Technical Advisory Committee (TAC) Meeting was called to order by Chair, Patsy Christie at 10:30 a.m.

(2) ROLL CALL OF MEMBERS

In-person attendees introduced themselves and Tim Conklin named the virtual attendees. Nicole Gibbs recorded member names and tallied votes. A quorum was reached.

(3) APPROVE TAC JULY 15, 2021 MEETING MINUTES

Chair Patsy Christie asked the Committee whether there were any additions or corrections to the July meeting minutes and hearing none, requested a motion to approve the July 15, 2021 TAC Meeting Minutes.

MOTION: Mayor Chris Moore made a motion to approve the July 15, 2021 TAC Meeting Minutes as distributed. Dan Weese provided the second. Motion passed unanimously.

(4) ARDOT BRIDGE INTERACTIVE MAP TOOL DEMONSTRATION – Kevin Weston, ARDOT

Chair Patsy Christie introduced the item, with Elizabeth Bowen introducing Kevin Weston with ARDOT. Weston gave the TAC an overview of the ARDOT interactive web tools available at ardot.maps.arcgis.com. Weston provided the following links to access the various tools:

(5) STBGP-A AND TAP – FFY 2021 OBLIGATION STATUS

Tim Conklin explained that a few more projects have been obligated since we last met and he summarized the status on the projects not yet obligated. He said there will potentially be \$1.1M in carry-over. Conklin thanked everyone for working with himself and ARDOT, and thanked ARDOT program management for helping us over the last few weeks to get these projects obligated. He explained that if one or more projects do not meet their deadlines, we will juggle qualified projects between federal fiscal years to ensure that we obligate all available money. (6) STBGP-A AND TAP – FFY 2022 PROPOSED PROJECTS – Recommendation to RPC/Policy Committee

Chair Patsy Christie introduced the item and Tim Conklin summarized the STBGP-A and TAP FFY 2022 Proposed Projects. The following information was presented visually:

- NWARPC received thirteen (13) project applications with a total request of \$8,660,319.
- Five projects are existing projects “in the pipeline” and eight (8) applications are for new projects.
- The Review Committee toured and scored projects on August 9, 2021.
- The assumptions for the FFY 2022 funding estimate is based on FFY 2021 FAST ACT actual apportionments with an assumed 100% obligation limitation (OL) (Note: FFY 2021 OL is currently at 89%).

Tim Conklin explained that the Review Committee did not have a formal vote, but the discussion with the Committee and the general consensus was to move them all forward for approval as submitted since we anticipate having the funds for all projects requested for FFY 2022. Conklin further explained that ordinarily we have awarded around \$500K of TAP money, which is typically split between two projects. However, we do show \$626K being awarded to TAP projects. He said

that Highway Infrastructure Program (HIP) funds are included in this process and together, it is anticipated to be able to cover all funding requests.

Tim Conklin showed the overall project list with funding recommended at 100% and explained again that typically some projects have to step aside or do not rank high enough, but this year we anticipated having enough funding to cover all project requests. He stated that staff recommendation is to fund the projects as submitted, awarding about \$8.6M, and taking that to the RPC/Policy Committee for their approval.

Chris Brown asked about the new Infrastructure Bill and the potential for more money coming into the FFY 2022 budget. Tim Conklin explained the current funding estimates are based on the past year's funding, however, there is the potential for changes once the U.S. House passes the new five-

year Infrastructure Bill. He said the other thing that will change our funding in the future is our increased population. He said if there is additional funding with the new Infrastructure Bill, we envision likely needing to do another call for projects in order to obligate any new funds that become available.

Chair Patsy Christie stated that now is the time to get projects ready because hopefully there will be additional funds that we all need to be ready to start using.

Chair Christie asked the Committee whether there were any questions or comments on this item. Hearing none, she asked for a motion to move this forward by recommendation to the RPC/Policy Committee, who will be meeting next week.

MOTION: Dennis Birge made a motion to recommend to the RPC/Policy Committee approval of the FFY 2022 STBGP-A and TAP projects as shown in the funding allocation table. Brad Baldwin provided the second. Motion passed unanimously.

(7) NARTS FFY 2021-2024 TIP AMENDMENT #2 – Approval to Enter into Public Comment Period

Chair Patsy Christie introduced the item and Tim Conklin explained that we are required to add a discussion of Transit Safety Targets into the TIP if we touch our TIP after July, and the Section 5310 Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) funds have to be added to the TIP and STIP. He said our region receives about \$38K for 5310 Enhanced Mobility of Seniors and Individuals with Disabilities funds.

Tim Conklin stated that we need a recommendation from TAC to send this to public comment and that we anticipate doing a ballot vote on this amendment.

Chair Christie asked the Committee whether there were any questions or comments on this item. Chris Dillaha with ARDOT stated that the total shown on the screen was an old total, and the correct total should be \$590K.

Chair Christie asked for a motion to send this to a two-week public comment period.

MOTION: Kevin Johnston made a motion to approve entering into a two (2) week public comment period for to the FFY 2021-2024 TIP Amendment #2 as presented. Chris Dillaha provided the second. Motion passed unanimously.

(8) ACTIVE TRANSPORTATION COMMITTEE (ACT) UPDATES

A. NWA Bicycle and Pedestrian Master Plan

Chair Patsy Christie introduced the item and Elizabeth Bowen explained that the update to the 2014 NWA Bicycle and Pedestrian Master Plan was introduced to the Committee at last month's meeting. Bowen said there is a lot of information that needs to be updated in the plan, including around eight amendments that will be incorporated, plus additional federal and state guidelines that will go into the plan. She said the Existing Conditions, Regional Bicycle & Pedestrian Network, and Individual Community Action Plans chapters will all have significant change. She said the update will take place over the next eleven months, with the kick off meeting being this afternoon. She asked each City and County to send a representative to that meeting so that we can explain the process and find out

whether you want to do a full update to your local plan, or amend it according to plan recommendations.

B. Butterfield Stage Experience Route

Elizabeth Bowen said last month we discussed designating this new route with TAC and RPC/Policy Committee. She showed and summarized the communities that have approved the route through their communities and those that are still reviewing the routes.

Chair Patsy Christie asked whether there were any questions or comments and there were none.

(9) CONGESTION MANAGEMENT PROCESS (CMP)

Elizabeth Bowen explained that we are under federal requirements to update our CMP and we have received a Notice to Proceed as of July 29. She said we are using ARDOT’s consultant contracting process. She stated that a kick-off meeting was held on August 10, which started the seven-month process. She explained the contract originally described an end date by the end of this year, however, the contract will need to be amended to extend to the end of February based on when we received the Notice to Proceed.

(10) TRANSPORTATION SYSTEMS MAINTENANCE AND OPERATIONS (TSMO)/INTELLIGENT TRANSPORTATION SYSTEMS (ITS)

Elizabeth Bowen explained the 2007 ITS is being updated, and the TSMO is a new plan. She said we received our Task Order and Notice to Proceed on August 12, and next steps include holding a kick-off meeting and agreeing on a timeline for the TSMO and ITS projects, which are both 18-month processes. She said we are coordinating with ARDOT as they are updating their TSMO and ITS at the same time.

Elizabeth Bowen asked whether there were any questions or comments and there were none.

(11) PUBLIC COMMENT – *Any public comment received via email will be provided to TAC members prior to meeting, and will become part of the meeting record.*

Chair Patsy Christie asked if any comments had been received prior to the meeting. Nicole Gibbs stated that two comments were received pertaining to the Razorback Greenway and that they were forwarded to the Razorback Greenway Alliance to address.

Chair Christie asked if there was anyone at the meeting that wished to comment. No additional comments were made.

(12) OTHER BUSINESS

A. Water + Wastewater Grant Opportunity (American Rescue Plan Act of 2021)

Chair Patsy Christie introduced the item and Elizabeth Bowen explained that the Illinois River Watershed Partnership (IRWP) approached NWARPC a couple months ago about doing a regional stormwater assessment for the watershed. She said we brought the request to the RPC/Policy Committee in July and were approved to continue developing the project proposal and to include other watersheds within the Benton and Washington County areas. Bowen explained that during this process we found that there are other opportunities for funding. The following information was

Bowen explained that NWARPC submitted a \$6M request for this project in the Department of Agriculture's Needs Survey, including all seven watersheds. She said the preliminary scope of work can be adjusted based on the amount of funding that can be made available.

Bowen asked whether there were any questions. Chris Brown asked when there will be an ask from the Cities. Bowen stated that currently there is no funding request from the Cities or Counties for this project. We are just asking for your participation at this time in order to achieve the best product and end result.

B. Census data

Tim Conklin stated that NWARPC sent out 2020 Census data to our members and you can also find census data at <https://arstatedatacenter.youraedi.com/census-2020/>. Conklin said that Benton and Washington Counties grew by 105,800 people in the last decade and were the fastest growing counties in the state. He also summarized other growth information for the region and said that Regional Planning will be working with jurisdictions and school districts to help with the redistricting process. Chair Patsy Christie asked for clarification on whether the data is out in a form that redistricting can start. Conklin explained that they are pulling the legacy data and processing it for redistricting and that data has been used in the past.
