#### (1) CALL TO ORDER

The in-person and virtual NWARPC Technical Advisory Committee (TAC) Meeting was called to order by Chair, Patsy Christie at 10:30 a.m.

#### (2) ROLL CALL OF MEMBERS

In-person attendees introduced themselves and Tim Conklin named the virtual attendees. Nicole Gibbs recorded member names and tallied votes. A guorum was reached.

#### (3) APPROVAL OF AUGUST 19, 2021 TAC MEETING MINUTES

Chair Patsy Christie asked the Committee whether there were any additions or corrections to the July meeting minutes and hearing none, requested a motion to approve the August 19, 2021 TAC Meeting Minutes.

MOTION: Mayor Jeff Van Sickler made a motion to approve the August 19, 2021 TAC Meeting Minutes as distributed. Mayor Bill Edwards provided the second. Motion passed unanimously.

### (4) 2022 ARDOT + MoDOT SAFETY PERFORMANCE TARGETS – Recommendation to RPC/Policy Committee

Chair Patsy Christie introduced the item, with Tim Conklin explaining that we look at three (3) Federal Highway Administration (FHWA) Performance Measures (PMs): Safety, Pavement and Bridges, and System Performance. We also consider two (2) Federal Transit Administration (FTA) PM's: Transportation Asset Management (TAM) and Public Transportation Agency Safety Plan (PTASP). He said today we are considering five (5) Safety Performance Targets from ARDOT and MoDOT. He said Federal law requires MPO's to pass a resolution within 180 days supporting the State DOT's annual targets, or we as an agency can set our own targets. He said we have opted to support both ARDOT and MoDOT's established targets. Conklin said that we are also required to report our baseline condition and performance in our 2045 Metropolitan Transportation Plan, which we did last year with the adoption of that plan. He described and presented the following targets visually:

Conklin further explained that there is a process that both State DOT's go through to engage the MPO's in the Spring and over the Summer to set these targets now adopted by the respective DOT Commissions. He said if anyone is interested in how these targets are set and what assumptions are used, NWARPC does have documentation.

Chair Patsy Christie asked whether there were any questions and hearing none, requested a motion to make a recommendation to the RPC/Policy Committee for these Safety Performance Targets.

<u>MOTION:</u> Mayor Chris Keeney made a motion to recommend to the RPC/Policy Committee approval of the CY 2022 MoDOT and ARDOT Safety Performance Targets. Mayor Jeff Van Sickler provided the second. Motion passed unanimously.

#### (5) FFY 2022 STBGP-A AND TAP PROJECT DEVELOPMENT

Chair Patsy Christie introduced the item, with Tim Conklin explaining in August the RPC/Policy Committee voted to award funding to the 2022 projects. He said in order to get the new projects going, you will need to have a project initiation meeting with ARDOT and provide them with the award letter from NWARPC. He said there is also a new ARDOT requirement for quarterly progress reports on TAP projects. Conklin summarized and presented the list of 2022 projects as follows:

Conklin mentioned that Congress will need to act in order to have any of these funds in 2022. He said the total funding is estimated based on 2021 funding, and we are not certain at this point what the results of the proposed Infrastructure Bill will be on the actual funds coming to our region.

Conklin said that everyone should be aware that there is a Local Public Agency (LPA) Project Manual with steps you need to take for your projects (<a href="https://www.ardot.gov/wp-content/uploads/2021/06/FINAL\_LPA-Manual\_v26-14-21.pdf">https://www.ardot.gov/wp-content/uploads/2021/06/FINAL\_LPA-Manual\_v26-14-21.pdf</a>). He asked that project managers review this manual and be aware that you are not to move forward without ARDOT approving your projects, bids, environmental, etc. He showed an example of the LPA Project Quarterly Report Form and shared contact information for the Local Project Administrator.

Chair Patsy Christie asked whether there were any questions and there were none. She wished those starting new projects good luck.

#### (6) PROJECTS AND OTHER UPDATES

### A. Census and Redistricting Information

Tim Conklin explained that NWARPC has offered to do redistricting for the School Districts, Counties, and Cities and you can still contact Jeff Hawkins if you would like our help. Tim summarized Census population changes in the region, saying the two-county area grew by 105,800 people from the 2010 Census, with the largest four cities growing by 67,540 people, which is 63.84% of the two-county growth. He also showed and explained that the largest City, Fayetteville, only accounts for 17.72% of the two-county population, which shows that we do not have one core city, but are a polycentric region with multiple jurisdictions that have to work together to connect trails, transit, and roads. He also showed and explained that in 1990, Fayetteville and Springdale accounted for 96% of the Urbanized Area, and the UZA was entirely within Washington County. He said by 2000, Fayetteville had about a third of the population, with Benton County cities being added into the UZA; and by 2010, Fayetteville dropped down below a quarter of the population, with the population evenly split between Benton and Washington Counties. He said while the 2020 UZA has not yet been published, the Urbanized Area population is utilized in many of the Federal funding formulas, including STBGP-A and TAP, as well as transit funding.

Patsy Christie asked Jeff Hawkins how soon cities would be getting new ward information. Hawkins explained that there are a lot of moving parts, and common lines can be used if there is an order of who does what and when. He explained the Congressional Districts are done by the legislature and they have adopted a Bill; the House and Senate Districts are done by the State Board of Apportionment, which are expected to be posted by the end of this month, with a 30-day review period before becoming final. He said it was not possible to wait until the House and Senate districts were approved to start the School Zone redistricting, and plans have been prepared for all nine (9) districts that previously had zones, with an additional six (6) School Districts having to use zones for the first time. He explained that it is possible to wait for the draft House and Senate map to follow some of their lines for the Justice of the Peace Districts, which are done by the County Board of Election Commissions. He said NWARPC has a couple drafts done in one county and starting to work on the other one now, noting significant population changes in Benton County JP districts in particular. He explained that redistricting is done based on total population, *not* voting age population.

Hawkins said the schedule for City Wards is different by law than School Zones and Quorum Court Districts, with the authority to redistrict resting with the City Council, and with no statutorily specific time requirement after the Decennial Census. He mentioned, however, the law does say that it is the Council's duty to see to it that the wards are of substantially equal population, and mentioned scenarios in which Councils may decide to redistrict apart from the Decennial Census. He said they will begin working on City Wards as soon as we finish up with the Counties, likely in November. He said Siloam Springs will be first because they are on a different election cycle with the City Administrator form, and the other cities will follow. NWARPC will prepare alternate plans to equalize the population for Cities, unless they tell us they will be doing their own redistricting.

Chair Christie asked whether there were other questions and there were none.

Elizabeth Bowen explained we are in the process of updating our 2015 Congestion Management Plan (CMP) and summarized and presented the following updates:
