# PUBLIC NOTICE TWO-WEEK PUBLIC COMMENT PERIOD

TO RECONCILE THE NARTS FFY 2021-2024 TIP WITH THE DRAFT

FFY 2023-2027 MISSOURI STATE TRANSPORTATION IMPROVEMENT PROGRAM (STIP)

#### MISSOURI STIP and NARTS TIP:

- The draft 2023-2027 Missouri Statewide Transportation Improvement Program (STIP) lists transportation projects planned by state and regional planning agencies for fiscal years 2023 through 2027 (July 1, 2022 June 30, 2027). The proposed program was available for public review and comment beginning May 18 and ending June 17, 2022. Following the public review, the comments will be presented to the Missouri Highways and Transportation Commission. The Commission will review the comments and the final transportation program before considering it for approval on July 6, 2022.
- The NARTS FFY 2021-2024 TIP was approved by the RPC/Policy Committee on December 2, 2020, see: <a href="https://www.nwarpc.org/transportation/transportation-improvement-program/">https://www.nwarpc.org/transportation/transportation-improvement-program/</a>.

Both the NARTS TIP, and the Missouri STIP, list projects for roadway, bridge, safety, intersection improvement and transit projects. The NARTS TIP is consistent with the NWA 2045 Metropolitan Transportation Plan (MTP) and the Missouri STIP is consistent with the state's Long-Range Plan.

The purpose of Proposed Amendment #4 is to reconcile the NARTS TIP with the Missouri STIP. The NARTS TIP is a component of the STIP, and as such, the projects, funding amounts and categories, FFY, etc., must match the STIP that the Highway Commission recently released.
