**(1) CALL TO ORDER**

The hybrid, in-person and virtual NWARPC/Policy Committee meeting was called to order by Chair, Mayor Chris Keeney at 1:33 p.m.

**(2) ROLL CALL OF MEMBERS**

In-person attendees introduced themselves and Tim Conklin named the virtual attendees. Nicole Gibbs recorded member names and tallied votes. A quorum was reached.

**(3) APPROVE RPC/POLICY COMMITTEE MEETING MINUTES FOR DECEMBER 7, 2022**

Chair Mayor Keeney asked whether there were any additions or corrections to the meeting minutes and hearing none, requested a motion to approve the December 7, 2022 RPC/Policy Committee Meeting Minutes.

**MOTION:** Mayor Ernie Penn made a motion to approve the December 7, 2022 RPC/Policy Committee Meeting Minutes as presented. Phillip Patterson provided the second. Motion passed unanimously.

**(4) DIRECTOR'S REPORT**

Tim Conklin said we have entered into a new lease at this location and the owner is going to be painting and laying new flooring. He said hopefully this does not interrupt our TAC and Policy Committee meetings next month. He said FY 2023 federal funding has been fully approved by Congress, signed by the President and the apportionment tables have been released. He said the federal funding that NWARPC receives is on the books and we will discuss amounts later on the agenda. He said there is a new person at the state doing the Clearinghouse review documentation, and we will be getting that information out to the Board.

Chair Keeney asked whether there were any questions and there were none.

**(5) NWARPC 2045 METROPOLITAN TRANSPORTATION PLAN (MTP) AMENDMENT #2**

Chair Mayor Keeney introduced the item and Tim Conklin explained that the Bipartisan Infrastructure Law (BIL/IIJA) introduced new federal funding programs that we are working to identify in our 2045 MTP. He said the Board approved amendment #1 in October 2022 to include the Carbon Reduction Program (CRP) and National Electric Vehicle Infrastructure (NEVI) Program. He said amendment #2 includes the Promoting Resilient Operations for Transformative, Efficient, and Cost-Saving Transportation (PROTECT) Formula Program. He reviewed the public hearing and comment period and said we did not receive any comments. He said he is happy to answer any questions.

**(6) 2023 ARDOT & MoDOT PERFORMANCE TARGETS FOR PAVEMENT AND BRIDGE CONDITION, AND TRAVEL TIME RELIABILITY**

Chair Mayor Keeney introduced the item and Tim Conklin explained that both ARDOT and MoDOT have provided us their two- and four-year targets for pavement and bridge condition, and system performance. He reviewed our MPO requirements to establish targets and said we have typically chosen to support the state DOT's targets rather than create our own. He summarized the ARDOT and MoDOT targets and showed the following table:

**A. RESOLUTION #2023-02** – Supporting the ARDOT and MoDOT Established Performance Targets for Pavement and Bridge Condition, and Travel Time Reliability

Chair Mayor Keeney asked if there were any questions and hearing none called for a motion to approve Resolution #2023-02 Supporting the ARDOT and MoDOT Established Performance Targets for Pavement and Bridge Condition, and Travel Time Reliability.

**(7) FY 2023 REBUILDING AMERICAN INFRASTRUCTURE WITH SUSTAINABILITY AND EQUITY (RAISE) GRANT APPLICATION FOR HIGHWAY 112 PROJECT AUTHORIZATION**

Chair Mayor Keeney introduced the item and Tim Conklin explained that the NWARPC approached ARDOT about supporting the Commission applying for a \$25 million RAISE discretionary grant for the Highway 112 project. He said ARDOT has agreed to support and carry out the project. He said the deadline for the RAISE application is February 28, 2023. He said the project is designed with 26 roundabouts, access management, raised medians, and a separated 12-foot trail, and the entire project from Fayetteville to Bentonville is fully funded within the Statewide Transportation Improvement Program (STIP/TIP). He said we adopted a Regional Vision in 2019 to establish a uniform design across the eight municipalities and two counties, and there have been numerous public involvement meetings for the design of the project. He thanked the communities who have provided letters of support and said this should be a very competitive project. He said the Benefit-Cost Analysis (BCA) is about 90% complete, and benefits to reduce Killed and Serious Injury (KSI) crashes over the next 30 years is significant, which makes the BCA ratio very high. Conklin said he is happy to answer any questions.

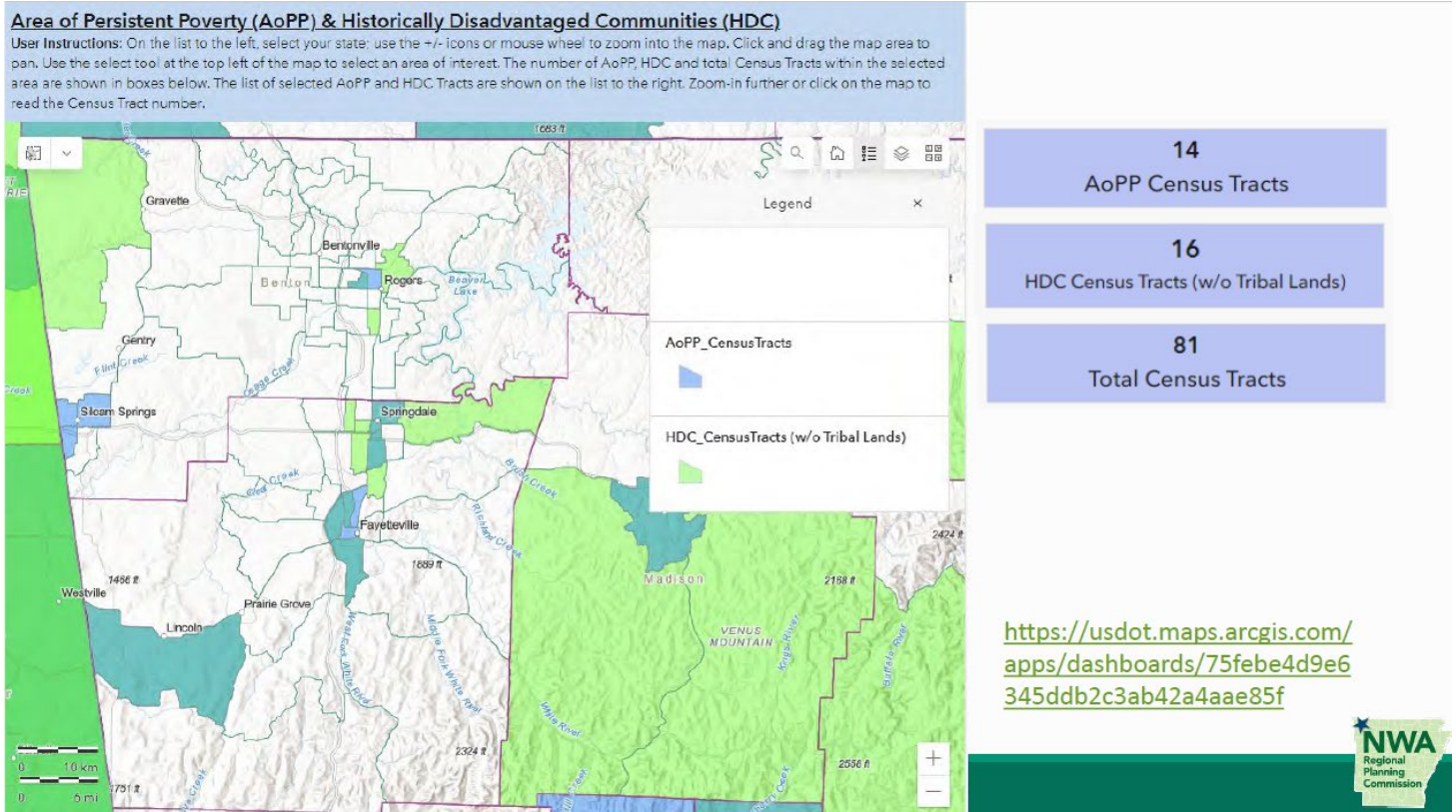

**(8) FY 2023 AREAS OF PERSISTENT POVERTY GRANT APPLICATION FOR BUS STOP ENHANCEMENT PROJECT AUTHORIZATION**

Chair Mayor Keeney introduced the item and Tim Conklin explained that Regional Planning, Ozark Regional Transit (ORT), and Razorback Transit have been meeting over the last few weeks to discuss applying for the FTA Areas of Persistent Poverty (AoPP) Discretionary Grant Program for engineering and design to begin implementation of the Bus Stop Enhancement Plan that was prepared last year. The NWARPC would be the applicant for a \$540,000 (90%) federal grant, with the local match of \$60,000 (10%) being split by ORT and Razorback Transit, for a \$600,000 project. He said the deadline is March 10, 2023 and Olsson is preparing the grant application. Conklin explained the Areas of Persistent Poverty (AoPP) and Historically Disadvantaged Communities (HDC) parameters and

showed the following, explaining that we are working with cities who have areas that fall into those categories:



Conklin highlighted some of the findings and recommendations of the Bus Stop Enhancement Plan. He said he is happy to answer any questions. There was discussion regarding co-using the stops for school bus use. There was discussion regarding there being room in the grant to refine the design and locations of bus stops being considered.

Conklin said the idea is that this grant would allow us to complete the engineering and design portions, which would then allow us to apply for additional FTA grants in the future to perform the bus stop improvements.

There was discussion about what constitutes Areas of Persistent Poverty (AoPP). Conklin said all the discretionary grant programs consider project locations and the administration's Justice40 program is focused on 40% of federal funds going to projects in these designated locations.

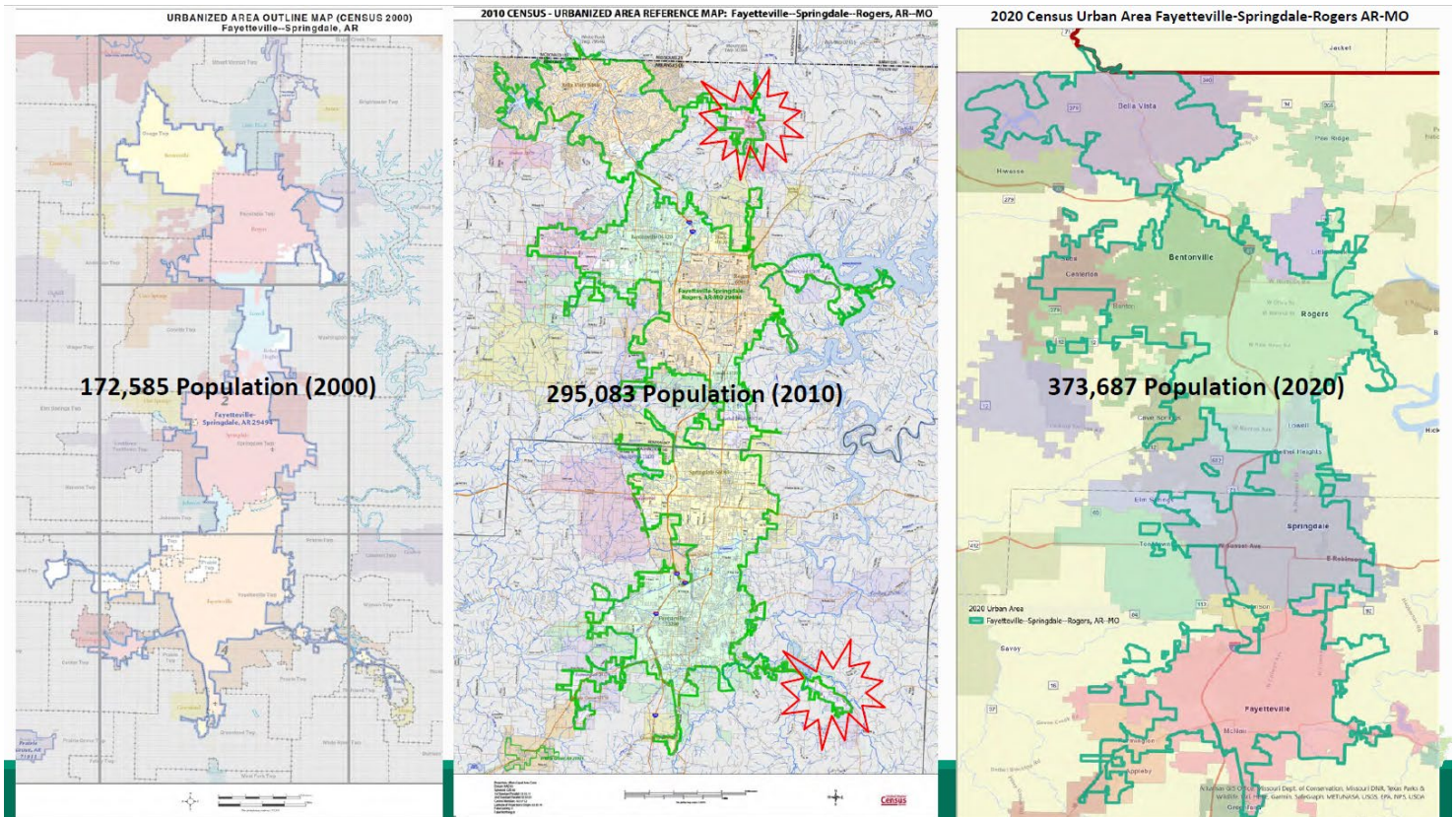


(9) PROJECTS AND OTHER UPDATES

**A. Urban Area Boundary and Population Update**

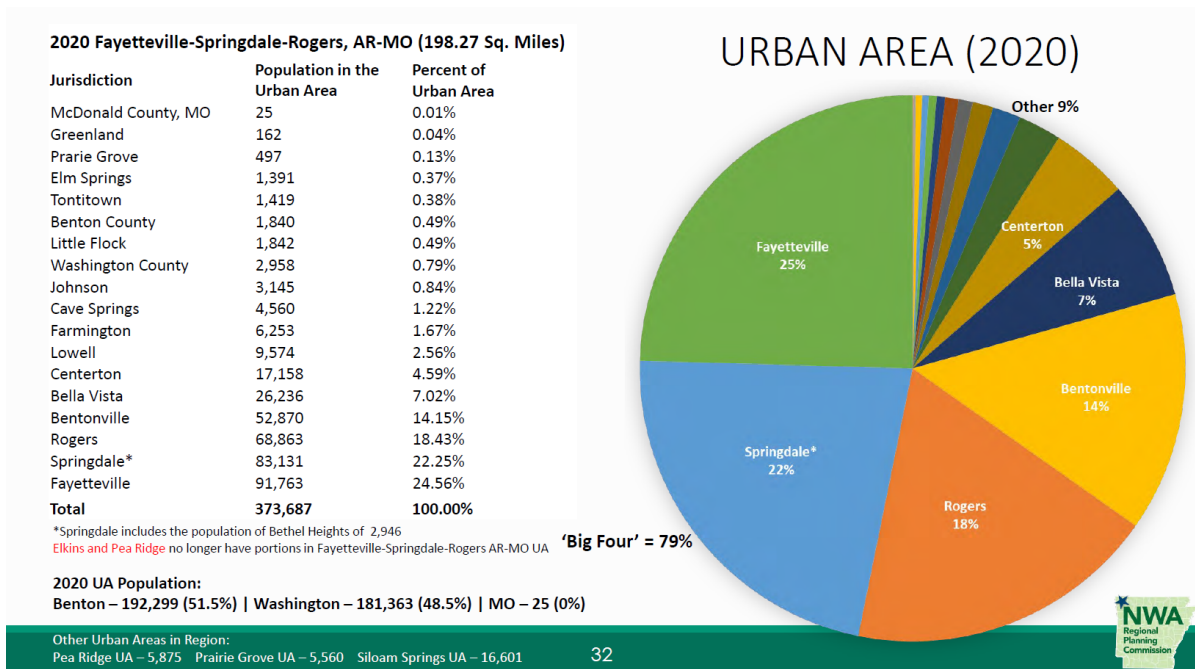
Tim Conklin explained that in December 2022 the US Census Bureau announced the Urban Area population. He said we compared our Fayetteville-Springdale-Rogers, AR-MO Urban Area to others such as Little Rock, Fort Smith, Jonesboro, AR; Springfield, MO; Tulsa, OK; Wichita, KS and we had the highest numeric increase in population (78,604) as well as the highest percent population change (26.6%) and population density change (313). He said there is no relation to city limits; this is a criteria that the Census Bureau considers with regard to housing unit density to distinguish urban and rural areas.

Conklin showed the following graphics illustrating the 2000 and 2010 Urbanized Areas and the 2020 Urban Area, noting that Pea Ridge, Elkins, and parts of Prairie Grove are no longer in the larger Urban Area based on the new criteria:



He said we looked at how the population is distributed across the Urban Area, and the big-four cities make up 79% of the Urban Area population. He noted that this distribution has changed dramatically since the 1990s with more and more smaller cities being included in the Urban Area.

Conklin said these numbers are important because federal-aid programs use these urban population numbers as part of their funding formulas and the new numbers will affect the suballocation of our STBGP, CRP, and TAP funds for the Fayetteville-Springdale-Rogers, AR-MO Urban Area. He said working with Metroplan, we believe we will receive an additional \$2 million for our area starting in FY 2024.

There was discussion regarding those communities outside or no longer within the Urban Area. Conklin said that we have awarded NWARPC funding to areas outside the Urban Area. He said ARDOT has an intersection program funding that they do not allow to be spent inside the Urban Area. He also noted that many discretionary programs ask whether the project is urban or rural. He said we do have other Urban Areas under 50,000 in population, for which we do not receive suballocated funding. He said only the population in Urban Areas over 200,000 receive federal formula funding. Jeff Hawkins said the transit funding for capital and operating assistance is also based on the Urban Area population, so that will go up as well in FY 2024.

## **B. STBGP-A/TAP/CRP Project Development**

Tim Conklin explained that your FY 2023 Agreements will be triparty, which will include NWARPC. He said TAC brought up in the meeting last week that many communities are still waiting on their Agreements of Understandings (AoU). He said he spoke with Program Management on Monday, and they assured him they are working to get the Agreements to our communities.

Conklin explained that the apportionment tables have been published and summarized the following:

Conklin said for those that are new to the Commission, we already awarded the FY2023 money back in August 2022. He said we will estimate the FY2024 money and do a project selection beginning this Spring and will vote on projects in August 2023. He said we believe the \$11.5 million total will go up \$2 million in FY2024.

Conklin said the status of these projects are very important because ARDOT's policy is that we can only carry over \$1 million in federal funding year to year. He explained that as we get more total funding and more projects in the pipeline, this becomes more difficult to accomplish.

### C. Bipartisan Infrastructure Law (BIL) (aka IIJA) Updates

Tim Conklin summarized various dates and deadlines for discretionary grant programs. He said the RAISE grant application authorized earlier is due February 28, 2023. He said everyone needs to be thinking ahead about projects they believe can compete for these programs. He shared the following links to grant resources:

Conklin said there is a new Active Transportation Infrastructure Investment Program (ATIIP) they pushed out this year for projects that connect active transportation networks and spines, such as the Razorback Greenway.

### D. NWARPC Carbon Reduction Program (CRP) Update

Elizabeth Bowen explained that last year was the first year that CRP funds were available. She said NWARPC has been allocated about \$2.2 million in Carbon Reduction Program (CRP) funding for FFYs

**F. Regional Comprehensive Safety Action Plan (CSAP) Update**

Elizabeth Bowen announced that we were awarded \$300,000 FY 2022 Safe Streets and Roads for All (SS4A) CSAP Planning Grant, which will be used in place of the STBGP-A funds that we set aside for this project to get started.

Bowen summarized a breakdown of the FY 2022 program awards, including 473 Action Plan Grants, and 37 Implementation Grants. She said the reason we set aside STBGP-A funds is so that we could get a plan in place to be able to apply for Implementation Grants in the next grant cycle. She said with TAC last week, we did an analysis of the awards to help us strategize future applications. She showed the following information:

The USDOT is awarding **473 Action Plan Grants** and **37 Implementation Grants** in this first round of the program.

Tim Conklin said the Notice of Funding Opportunity (NOFO) for SS4A Implementation Grants is expected to come out in April, with the application deadline most likely in September. He said if you anticipate applying for an SS4A Implementation Grant, that work will need to start around May to hit the September deadline. He said the goal is to complete the plan by September.

Conklin thanked the Walton Family Foundation, who provided the local match for this CSAP.



