(1) CALL TO ORDER

The in-person and virtual NWARPC Technical Advisory Committee (TAC) Meeting was called to order by Chair Patsy Christie at 10:30 a.m.

(2) ROLL CALL OF MEMBERS

In-person attendees named themselves with Tim Conklin naming the virtual attendees. Nicole Gibbs recorded member names and tallied votes. A quorum was reached.

(3) APPROVAL OF THE FEBRUARY 16, 2023 TAC MEETING MINUTES

Chair Christie asked the Committee whether there were any additions or corrections to the meeting minutes and hearing none, requested a motion to approve the February 16, 2023 TAC Meeting Minutes.

MOTION: Mark Latham made a motion to approve the February 16, 2023 TAC Meeting Minutes. Chris Dillaha provided the second. Motion passed unanimously.

(4) FY 2023 CARBON REDUCTION PROGRAM (CRP) PROJECT SELECTION – Recommendation to RPC/Policy Committee

Chair Christie introduced the item and Elizabeth Bowen explained that NWARPC has been allocated about \$2.2 million in Carbon Reduction Program (CRP) funding for FFYs 2022 and 2023. She said we reserved \$50,000 for the development of a CRP Plan, and awarded about \$1.5 million in December 2022, leaving about \$690,000 of funding still available.

Bowen summarized and showed questions that were sent to clarify program eligibility and requirements for projects awarded in the first round of funding, along with the responses that have been received from FHWA:

Questions for ARDOT and/or FHWA Division Office

- Q: Please review and verify that the street light LED project and video detection/monitoring
 equipment projects are eligible CRPprojects and meet the listed project types in the CRP guidance (i.e.
 do not require a demonstration of a reduction in transportation carbon emissions).
 A: These projects are eligible CRP projects based on the guidance. No demonstration of reduction is
 required.
- Q: Please review and comment on the use of sole source procurement for the purchase of the equipment -videocards and video detection equipment -for both Fayetteville and Lowell.
 A: A final rule was issued on this in September 2019. Here is a <u>link to the final rule and FAQs on the Final Rule</u>. Based on that, a public interest finding is no longer required for proprietary items. If you have any additional questions, just let me know.
- 3. Q: Please comment on how the ARDOT LPA process might be handled for the purchase and installation of the equipment. Will ARDOT review equipment specifications, cost of installation, and verify/inspect the installation? (Note -Fayetteville is requesting to use city forces for the installation of equipment). (Still awaiting response from ARDOT)

Bowen summarized the following timeline:

- Second Call for Projects December 11, 2022
- Application Deadline (Resolution Required) February 14, 2023, at 4:00pm
- Project Sponsor Presentation to TAC Committee February 16, 2023 at 10:30am
- Selection Committee Site Visit, Scoring, Recommendation February 27, 2023
- Project Selection Committee Recommendation to TAC March 16, 2023 at 10:30am
- Project Selection Recommendation to RPC/Policy March 22, 2023 at 1:30pm

Bowen briefly reviewed the approved program focus areas and summarized other program requirements, which were discussed with the Selection Committee.

Bowen summarized the activities and discussions as follows:

- Selection Committee James Boston (Decatur), Kevin Moore (Siloam Springs), Alan Craighead (Centerton), Chuck Jacobus (Goshen), Kent Laughlin (Rogers), Mike Peters (Springdale), and Paul Libertini (Fayetteville)
- Site visits visited all sites
- Score projects all projects were considered
- Discussed max/min awards per application
- Reviewed LPA Manual process and timeline
- Developed recommendation for TAC

Bowen said they discussed in detail where each project is in the process to determine which projects would be able to obligate the funding before the deadline. She further summarized the following committee discussion items:

Selection Committee discussion included:

- Siloam Springs application withdrawn
- Centerton application reduced to \$25,000 *
- Roger's projects #1 and #2 were combined for bid
- Projects that could be awarded in 1-3 months
- Projects that were seeking to reach 80% federal
- Providing funding to project 1 and remaining to project 2
- Providing funding to smaller city projects
- Discussed if amount of carbon reduction a consideration

Bowen explained that \$50,000 of FY 2023 STBGP-A funding was set aside to produce a Carbon Reduction Strategy. She said the state is required to create a strategy by November 2023 and staff feels we should delay completing a regional plan until after ARDOT's plan is complete, during FY 2024. She said staff made the recommendation to the Selection Committee to consider how to reallocate the \$50,000 of 2023 funding should the Policy Committee agree to move the work to FY 2024.

Bowen summarized the Selection Committee rankings and recommendations as follows:

Bowen explained that we have prepared the draft paper application as we have done since 2013. She said ARDOT has implemented an online application process this year and we have discussed internally if we would like to similarly do an online application. She said the downside to an online application is that you have to input everything at one time and cannot go back to your application at a later time. She asked for the committee's opinion. There was discussion and it was decided to remain with the paper application as we have done in the past.

Bowen said with the decision to stay with paper applications, we are able to move up the call for projects to March 23, 2023 in order to give everyone an extra month to get their applications together. She said the rest of the timeline would remain the same. There was discussion and it was decided to issue the notice as soon as possible.

Chair Christie requested a motion to recommend to the RPC/Policy Committee to authorize the FY 2024 Call for Projects on March 23, 2023.

<u>MOTION:</u> Mayor Chris Keeney made a motion to recommend to the RPC/Policy Committee to authorize the FY 2024 Call for Projects on March 23, 2023. Aaron Pile provided the second. Motion passed with no opposition.

(7) 2025-2028 STATEWIDE TRANSPORTATION IMPROVEMENT PROGRAM (STIP/TIP) DEVELOPMENT

Chair Christie introduced the item and Tim Conklin explained that we just adopted our 2023-2026 TIP, and we are now getting ready to update the TIP/STIP again. He said ARDOT has provided the following timeline:

DRAFT 2025-2028 Development Schedule

- March 31, 2023 –Proposed projects from MPO's due to ARDOT
- February 2024 –Initial draft STIP/TIP
- June 2024 –DRAFT STIP/TIP for public comment
- July/August 2024 –TIP Approval
- November 2024 –FHWA/FTA Approvals

Conklin said they are looking for our listed projects for our region by March 31, 2023. He said what we have done in the past is to provide what was voted on by TAC and RPC/Policy Committee as part

of our long range transportation plan since that had robust public involvement and numerous meetings through committees. He showed the following and highlighted some of the listed projects:

Conklin said obviously there is only so much funding in the four year period, and we are very thankful that we have all of Highway 112, the Airport Access Road, Highway 612 Bypass from 112 to Tontitown shown in the current STIP/TIP. He said hopefully in the future we will see funds for 612 from I-49 over to Hwy 265, but we do show those in the constrained project list that will be sent to ARDOT for their project development process. He said we also have numerous studies that have been done along our corridors that fall into this list.

Chair Christie asked whether there were any comments or questions and there were none.

(8) PROJECTS AND OTHER UPDATES

A. FY 2023 STBGP-A/TAP/CRP Project Development

Tim Conklin said he spoke with ARDOT this morning about the triparty agreements for projects that were awarded last fall, and they said the agreements were all drafted, and they are currently being reviewed by other departments. He said it is hard to obligate our money when we cannot get our projects going from what we selected in August. He said we will continue to work with our planning partners to make progress.

B. Bipartisan Infrastructure Law (BIL) (aka IIJA) Updates/USDOT Grant Updates

Tim Conklin said we submitted the Rebuilding American Infrastructure with Sustainability and Equity (RAISE) grant for \$25 million for Highway 112 and thanked Lorie Tudor for supporting that application and ARDOT staff for their assistance, along with the NWA Council for their support in helping us to get the Benefit Cost Analysis (BCA) complete. He said we also completed the \$540,000 FTA Areas of Persistent Poverty (AoPP) grant for bus stop improvements in our region. He said Ozark Regional Transit (ORT) and Razorback Transit will be responsible for splitting the local match of \$60,000. He

said for the application, ORT had additional Walton Family Foundation grant funds for Olsson to prepare the grant application, which was very helpful.

Conklin said these grants are very intensive and encouraged everyone to think ahead about projects they believe can compete for these programs. He shared the following links to grant resources:

Conklin said there is a new Active Transportation Infrastructure Investment Program (ATIIP) they pushed out this year for projects that connect active transportation networks and spines.

Conklin said the Charging and Fueling Infrastructure (CFI) Discretionary grant program NOFO has been issued, with proposals due May 30, 2023. He said we plan to pull our EV Working Group together again in late April.

C. Regional Comprehensive Safety Action Plan (CSAP) Update

Elizabeth Bowen summarized the project, recent work, and next steps as follows:

- NWARPC has contracted with Toole Design Group to develop the NWA Regional Comprehensive Safety Action Plan (CSAP) –Vision Zero
 - o Reduce fatalities and serious injury crashes on our transportation system

Bowen explained that we had set aside \$400,000 in STBGP-A funding and have a matching grant from the Walton Family Foundation. She said on January 31, 2023, we were awarded a \$300,000 USDOT Safe Streets and Roads for All (SS4A) Action Plan Grant and are working with FHWA to expedite our agreement so we can begin to use those funds and release around \$250,000 STBGP-A funds back into our pool for FY 2024 projects. She said this project is moving very quickly; it typically would take about 18 months to do this type of work, but we are doing it in 10 months so that communities and the region can apply for implementation grants in the FY 2023 SS4A funding cycle.

Conklin said the big takeaway for communities is to identify capital improvement projects that are safety-related and ensure they are recognized in this plan. He said communities that have areas of persistent poverty and historically disadvantaged communities will particularly be competitive in these discretionary grant programs.
