RE: NARTS FFY 2025-2028 TRANSPORTATION IMPROVEMENT PROGRAM (TIP) AMENDMENT #3 APPROVAL

All:

The Northwest Arkansas Regional Planning Commission (NWARPC), in conjunction with the Arkansas Department of Transportation (ARDOT), have determined an amendment to the Northwest Arkansas Regional Transportation Study (NARTS) FFY 2025-2028 Transportation Improvement Program (TIP) is necessary to include the Western North-South Connector project development.

The NARTS TIP and the Arkansas and Missouri STIPs list projects for roadway, bridge, safety, intersection improvement, and transit projects. The NARTS TIP is consistent with the NWA 2045 Metropolitan Transportation Plan (MTP) and the Arkansas and Missouri STIPs are consistent with their Statewide Long-Range Plans. The NARTS TIP is a component of the STIPs, and as such, the projects, funding amounts, categories, FFY, etc., must match the STIPs.

PUBLIC NOTIFICATION: In accordance with NWARPC's Public Participation Plan, notification was published in the Democrat Gazette on Sunday, September 7, 2025; the La Prensa Libre on Wednesday, September 10, 2025; the McDonald County Press on Thursday, September 11, 2025; and online at www.nwarpc.org/public-notifications/. A public comment period for TIP Amendment #3 began on Monday, September 8, 2025 and ran through Monday, September 22, 2025. Written comments were encouraged via email or using the comment tab on the NWARPC website. No public comments were received.

RECOMMENDATION AND APPROVAL: In accordance with NWARPC's Public Participation Plan, the Technical Advisory Committee (TAC) held a hybrid, in-person and virtual, meeting on September 18, 2025 and recommended the TIP Amendment #3 for approval. The RPC/Policy Committee held a hybrid, in-person and virtual, meeting on September 24, 2025 and approved Resolution #2025-18 Amending the NARTS FFY 2025-2028 TIP.

This approval letter, including Resolution #2025-18, has been incorporated into the NARTS FFY 2025-2028 TIP Amendments and Administrative Modifications on the website, which can be viewed at www.nwarpc.org/transportation/transportation-improvement-program/.

WHEREAS, Northwest Arkansas Regional Planning Commission (NWARPC) is the officially designated Metropolitan Planning Organization (MPO) and Federal Transit Administration (FTA) Designated Recipient for the Fayetteville-Springdale-Rogers, AR-MO Urban Area; and

WHEREAS, the MPO is charged with the responsibility of developing and administering the Transportation Improvement Program (TIP) for the Northwest Arkansas Regional Transportation Study (NARTS); and

WHEREAS, the NWARPC, in conjunction with the Arkansas Department of Transportation (ARDOT), have determined an amendment to the Northwest Arkansas Regional Transportation Study (NARTS) FFY 2025-2028 Transportation Improvement Program (TIP) is necessary to include the Western North-South Connector project development; and
